Health Care & Economic Security: In 2014, BayLegal helped over 6,247 low-income San Francisco Bay Area individuals, seniors, families with children, and disabled people gain access to essential health care and public safety-net programs including Medicare, Medi-Cal, Healthy Families, Supplemental Security Income, General Assistance, Food Stamps, and In-Home Supportive Services, and more. BayLegal works to ensure that the CalWORKs program serves as a bridge to gainful employment for its participants. Through this work, BayLegal secured over \$20,446,525 in quantifiable benefits to help low-income Bay Area residents meet their basic needs and improve their self-sufficiency. 4b (Code: ) (Expenses \$ 2,728,726. including grants of \$ 53,027.) (Revenue \$ 649.) Domestic Violence Prevention: In 2014, BayLegal provided integrated, holistic legal services to help over 8,475 low-income San Francisco Bay Area abuse survivors and their children escape domestic violence. BayLegal provides legal assistance with obtaining restraining orders, child custody orders, divorces, and child and spousal support orders. BayLegal also assists sexual assault victims and abused immigrants and their children petition for immigration relief under the Violence Against Women Act. Through this work, BayLegal secured \$4,340,170 in quantifiable benefits to help violence survivors achieve safety and improve their self-sufficiency.

4c (Code: ) (Expenses \$ 2,332,389. including grants of \$ 68,635.) (Revenue \$ 57,623.) Housing & Homelessness Prevention: In 2014, BayLegal helped 11,659 low-income San Francisco Bay Area individuals, seniors, families with children, and disabled people prevent homelessness and preserve and expand affordable housing by enforcing housing laws and regulations. BayLegal provided counsel and representation for clients who were victims of illegal evictions, including eviction after foreclosure; discrimination; substandard housing; and other housing rights violations. Through this work, BayLegal secured \$8,663,628 in quantifiable benefits to help low-income Bay Area residents secure their basic need for safe, affordable and habitable housing.
